We are pleased to present the report on the Postal Ballot conducted by **Novartis** India Limited ("the Company") seeking consent of its Members for the Special Resolution as contained in the Notice of Postal Ballot dated February 11, 2021.

- 1. In terms of provisions of Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014, we were appointed as the Scrutinizer by the Company on **February 11, 2021** to conduct the Postal Ballot as contained in the Notice dated **February 11, 2021**.
- 2. In terms of Sections 110 and 108 of the Companies Act, 2013, and all other applicable provisions, if any, of the Act read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, General Circular No. 14/ 2020 dated 8th April, 2020, General Circular No. 17/ 2020 dated 13th April, 2020, General Circular No. 22/ 2020 dated 15th June, 2020, General Circular No. 33/ 2020 dated 28th September, 2020 and General Circular No. 39/ 2020 dated 31st December, 2020 respectively (collectively referred to



as "MCA circulars"), in relation to "Clarification on passing of ordinary and special resolutions by companies under the Companies Act, 2013 and the rules made thereunder on account of the threat posed by COVID - 19" issued by the Ministry of Corporate Affairs, Government of India;

Members' approval was sought for the following:

- Re-appointment of Ms. Sandra Martyres (DIN: 00798406) as an Independent Director of the Company, to hold office for a term of 5 years with effect from April 19, 2021.
- The Company has informed that, on the basis of the Register of Members and the List of Beneficial Owners made available by the Depositories *viz.*, National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL), as on **Wednesday**, **February 17**, **2021** ("the cut-off date"), the Company completed dispatch of the Notice of Postal Ballot by E-Mail on **February 22**, **2021**, to **31,312** Members who had registered their emailids with the Company / Depositories.
- 4. In terms of the aforesaid notice, Members were required to convey their assent or dissent, through remote e-voting system, on e-voting platform provided by Link Intime India Private Limited from 9:00 a.m. (IST) on Tuesday, 23rd February, 2021 to 5:00 p.m. (IST) on Wednesday, 24th March, 2021.
- 51 Members had cast their votes on the remote e-voting platform till 5:00 p.m.
 (IST) on Wednesday, 24th March, 2021.
- 6. Members' demographic details, their voting rights and voting pattern were provided by Link Intime India Private Limited, Registrar & Transfer Agent of the Company.
- 7. After the scrutiny of the remote e-voting result, we report that the Special Resolution as contained in the Notice of Postal Ballot dated February 11, 2021 has been passed with requisite majority.

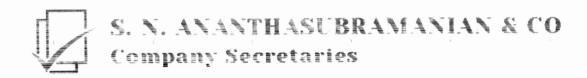
